Preparation for the event

## Digital Tickets:

All Tickets will be delivered digitally to the Account Manager's Ticketmaster account. Please have guest download the FREE Texas Motor Speedway app. Once tickets are transferred from you to your guests, they will receive an email confirmation with instructions to accept their tickets on the TMS mobile app. Each person will need a ticket on their mobile device to enter TMS gates.

## Track Pass:

On Sunday, suite level guests will receive a wristband when they arrive at the suite elevator tower. This wristband will allow suite entry/exit and allow suite guests to access the pits during designated times. The Sunday wristband is only for pit access/pre-race concert stage. The wristband does NOT grant access to garages or the grid.

Parking passes are also digital.

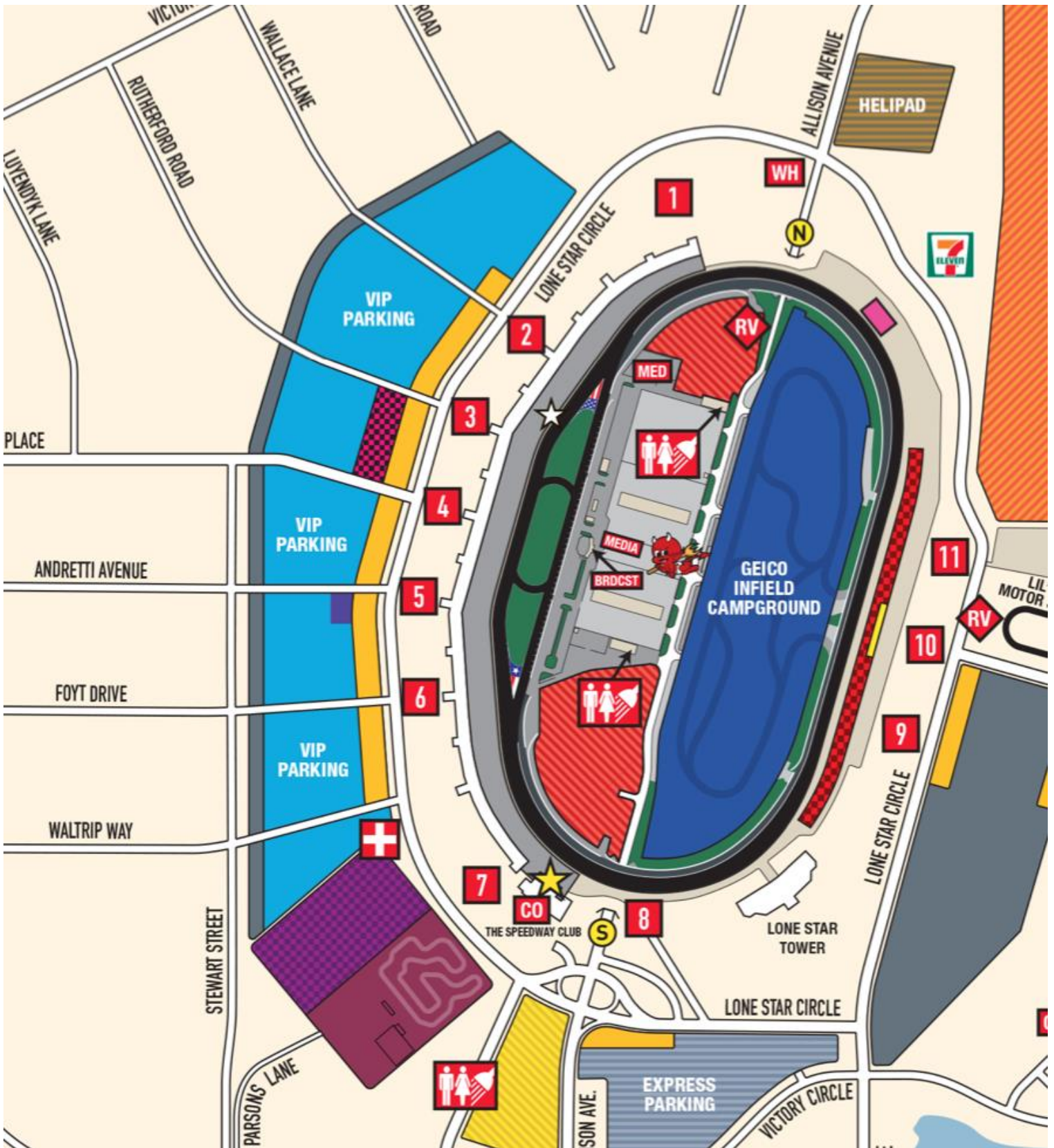

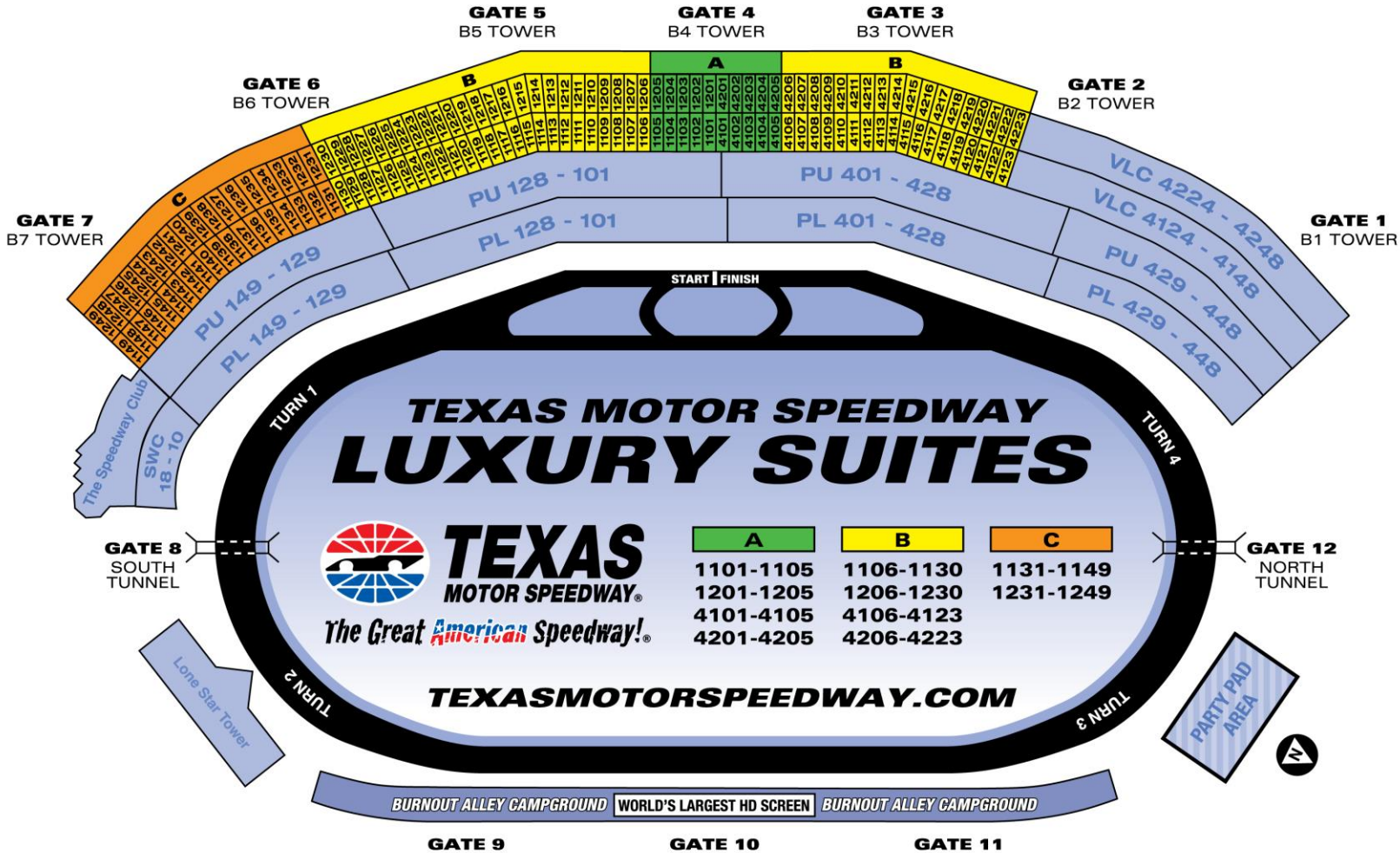

### **CORPORATE TICKET DOWNLOAD INSTRUCTIONS**

1. Go to [www.TexasMotorSpeedway.com/TicketManager](http://www.TexasMotorSpeedway.com/TicketManager)
2. Sign in with the email address on file
3. Create password or use your current password
4. Press "Manage Tickets"
5. Select the event (separate events for tickets and parking passes)
6. Press the transfer button, this is how you will distribute tickets to your guests
7. Select which tickets you would like to transfer, make sure seats are together if you need them to be
8. Click "Next"
9. Add recipients first name, last name, and email address
