

Texas Motor Speedway –“2021 Bristol Food City Dirt Race Watch-N-Win with Texas Motor Speedway Contest” Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

HOW TO PLAY: Beginning Monday, March 22, 2021 at 9:00am Central Standard Time (CST), potential participants can go www.TexasMotorSpeedway.com for three (3) official contest link(s) that correspond with each Food City Dirt Stage Race to enter-to-win. After clicking any of the Food City Dirt Stage Race contest link(s), potential entrants can opt to enter with their Facebook information or complete the required registration fields by providing a valid email, first and last name, phone number and name of the NASCAR Cup Series driver they predict will win the corresponding Food City Dirt Stage Races to complete the entry form and be deemed a valid entry.

Potential participants can enter to win each of the Food City Dirt Stage Race contest links until the green flag or official start of the corresponding Stage Race on Sunday, March 28, 2021 or whatever day that NASCAR deems the 2021 Bristol Food City Dirt Race takes place.

Limit one valid entry per person per Food City Dirt Stage Race contest link.
